As a Field Senior Electrician – Offshore your main job Activities are:

Tasks:

- Ensure that electrical activities are conducted in compliance with safety and environmental protection procedures.
- Ensure that the personnel, equipment and services are appropriate to the operational requirements.
- Participate in the training of junior personnel.

HSE:

A person in a supervisory or leading position is accountable to his manager for the implementation of the HSEMS within his area of responsibility.

As such his duties and areas of authority are:

- Setting a personal example in adherence to Company HSE procedures.
- Ensuring that Company rules and procedures are known and understood by them and their subordinates.
- Raising awareness and providing guidance in directing employees under their supervision with regard to the execution of the HSEMS, both for Company Staff and Contractors without detracting from Contractor's legal obligations.
- Ensuring compliance with Company Rules, Procedures and Instructions and applicable legislation
- Assuring themselves and the persons under their supervision of the safety of their work site before commencing work
- Taking the necessary measures to avert immediate threat of danger
- Exercising such caution as is necessary to avoid danger to persons and installations or avoid pollution

- The installations, equipment and tools.

- Ensure electrical rescue kits are available and in proper condition in all electrical stations.
- Carry out in person delicate/risky maintenance operations.
- Analyse electrical facilities and propose improvements.
- Anticipate potential problems and take corrective action with approval of supervisor.
- Prepare technical incident reports on major failures.
- Ensure technical management of activities.
- Contribute to improve skills and know-how of his team.
- Evaluate personnel under him in co ordination with supervisor.
- Carry out tool box talks and technical discussions with his team.
- Ensure maintenance activities are carried out according to the issued procedures. Ensure proper record are maintained for all activities.
- Carry out equipment replacement as part of obsolescence management.
- Optimise spare part usage and ensure critical spares are available.
- Carry out along with his team major trouble shooting activities.
- Carry out job and manpower planning for the routine maintenance activities.
- Ensure all electrical documentation available onsite are updated and all required documentation are available in each electrical station.
- Prepare permit to work and isolation permits
